- Entrance ways will be installed by the Township of Augusta under By-Law 3177-2015.
- Please attach a cheque in the amount of **\$100.00** made payable to THE TOWNSHIP OF AUGUSTA to this application for the Permit Fee or pay in person at the office. (Deposit is refundable if application is denied)
- The owner making the request for the installation is responsible for paying 100% of the cost.
- Entrance ways are not applicable to County Roads or Provincial Highways through the Township of Augusta.
- One (1) stake must be placed where the owner wishes to have the center of their entrance way before the site approval takes place and will be notified of dates and changes if necessary.
- Culvert extension costs will be determined by the Public Works Manager (as required).

STANDARD ENTRANCE IS 6 METRES IN WIDTH. ANY REQUEST FOR A CHANGE FROM A STANDARD ENTRANCE MUST BE REFERRED TO THE OFFICE.

According to By-Law 3177-2015, the minimum width of an entrance way is 6 metres due to the available lengths of culvert (standard). The costs listed below are for this 6-metre length of culvert. If a different width of entrance way is requested, the costs will vary accordingly. The types of culverts used are standard HDPE BOSS 2000 [(plastic pipe) 320 kPa] and the gravel used in installation is Granular M. The size of the culvert used will be determined by the Public Works Manager or Designate. The cost includes the culvert (couplers included), gravel, installation, compaction, grading, survey, and utility locates.
